## SIAE MEMBERSHIP CONDITIONS

### **PREMISE**

These requirements are notified pursuant to Article 5, paragraph 1, of the Legislative Decree no. 35 of 15 March 2017 implementing EU Directive 2014/26 (for both legislative texts, search on the website [www.siae.it](http://www.siae.it) at the Laws and Regulations section) and are written on the basis of SIAE's Articles of Associations and Rules, which are also available on the institutional website.

### **MEMBERSHIP REQUIREMENTS**

In accordance with the instructions available on the website [www.siae.it](http://www.siae.it), membership applications can be submitted by copyright holders as authors, publishers, producers, assignees and concessionaires, either natural or legal persons, Italian or foreign, heirs or successors in title of copyright owners. Membership is subject to the verification of compliance with the following minimum requirements:

- a) Society membership requires the no existence of final judgments for crimes related to copyright or offences against property, proven also by a statement from the applicant. The possible existence of convictions does not prevent from joining SIAE by giving a mandate for protection.
- b) Authors are required to register at least one work by using the form provided. In particular: i. for the Music Section the registration and deposit of at least one work is required; ii. for Theatre/Radio-TV Works Section, the registration and deposit of at least one work; iii. for Theatre/Radio-TV Works /Opera and Ballet Section, the registration and deposit of at least one work; iv. for Cinema Section, the registration of at least one work together with details on its first publication; v. for OLAF Section – Literary Works, the registration of at least one work already published or broadcast, together with the relevant documentation (i.e. the photocopy of the title page of the book, proof of the broadcasting of the work via radio, TV, web).
- c) Publishers or similar professionals (Producers, Assignees and Concessionaires) acting as commercial enterprises it is required the enrolment in the Register of Companies; for those carrying out a business activity on a complementary basis only, at least the enrolment in the Economic and Administrative Repertory (REA) or other Public Register is required. Moreover, the registration of at least one work through the provided form is required. In particular: for Music Section, the registration and deposit of at least 10 works in their original version; ii. for Theatre/Radio-TV Works Section, the registration and deposit of at least one work; iii. for Theatre/Radio-TV Works /Opera and Ballet Section, the registration and deposit of at least one work; iv. for Cinema Section, producers are required to supply information on at least one work produced in the last 3 years, while licensees/distributors are required to supply information on at least 6 works distributed in the last 3 years; v. for OLAF Section –Literary works, the registration of at least one work already published or broadcast is required, together with the relevant documentation (i.e. the photocopy of the title page of the book, proof of broadcasting of the work via radio, TV, web).

For the purpose of membership it is also required to give:

- 1) Communication of the method chosen for the payment of royalties possibly accrued;

- 2) Acceptance of these Membership Conditions;
- 3) No existence of undertakings with other collecting societies for the same repertoire, rights and territories for which SIAE's protection is required (self-certification contained in the membership application form);
- 4) Proof of payment of the annual contribution, where provided for.

The documents needed for identification of the applicant, as provided for in Article 1 of the General Rules. In particular:

- a) If an Author, a copy of a valid identity document and, if necessary, of the tax code<sup>1</sup> is required. In case of Authors under the age of 16, the presentation of the above-mentioned documents is also required for one of the applicant's legal guardians. In case of registration through the application available on *mobile* devices, and accessible only to authors over 16 years of age, identity recognition is also carried out through the recording of a video.
- b) If Publisher, Producer, Assignee or Concessionaire, the following documents are required:
  - i. Memorandum of Incorporation and Articles of Association (in original or certified copy) attesting, inter alia, that the company carries out a publishing activity related to the repertoire for which protection is asked for (exclusively for commercial enterprises);
  - ii. Certificate of incorporation issued not before than 3 months prior to the submission of the membership application;
- c) If Heir or Successor in title of copyright owners, the following documents are required:
  - i. Self-declaration affidavit pursuant to the Decree of the President of the Italia Republic no. 445 of December 28<sup>th</sup> 2000 or affidavit written by a notary public (however, in appropriate cases SIAE reserves the right to ask for the affidavit), containing:
    - 1) surname, name, marital status and date of death of the ex-member or ex-full member;
    - 2) Type of succession: testate or intestate;
    - 3) surname, name, place and date of birth of all legitimate, testamentary, apparent heirs and legatees, their present address and share of the estate;
    - 4) Last name, first name of the legal representative of the minor, debarred or incapacitated heirs, if any;
    - 5) Date of marriage, if any, last name, first name, place and date of birth and address of the surviving spouse (specify if it is the first or second marriage);
    - 6) Whether a divorce or separation decree was issued against the surviving spouse in any country or a marriage annulment final judgement was issued at the moment of the opening of the succession (if so, give details on the judgement);

- 7) Personal details and date of birth of the divorced spouse (or, if deceased, also the date of death) if there was a prior marriage;
- 8) If there is a will, that this is not opposed or contested (if this specification is not contained in the minutes mentioned at the following point 3);
- 9) That, except for the people referred to in the will, there aren't any other beneficiaries in the succession;
- 10) That the document is written for the heirs' joining SIAE and implies the acceptance of the succession by the heirs.
  - ii. certified copy of the possible waiver of the succession by any of the rightful heirs;
  - iii. Certified copy (by a Notary Public or Registrar of the Court, etc. – with original stamp and signature) of the minutes of will publication, if any, demonstrating that the will has not been opposed or contested;
  - iv. Certified copy of the divorce decree of which at point i. 6) above;
  - v. Decree of appointment of the guardian, deputy guardian, of interdicted or underage heirs or of the curator, if any, of underage, emancipated or incapable heirs etc., or supporting administrator;
  - vi. A legislative measure from the tutelary judge authorizing the guardian, curator or applicant according to the first paragraph of Article 321 of the Civil code to accept the inheritance, donation or legacy and to receive the revenue accrued and that will accrue in favour of the underage, interdicted, incapable heir etc. In case of a parent exercising the parental authority, only the authorization by the tutelary judge is needed in order to receive the revenue accrued and that will accrue in favour of the underage;
  - vii. In case of more than one heir having right in the succession, a proxy appointing a representative of the heirs. In the event that the deed is drawn up in a foreign country, the signatures must be certified by the Italian consulate. In case the deceased assignor was the owner of a publishing house (sole proprietorship) SIAE's member, the heirs shall indicate in the document, in addition to the name of the heirs' representative, also the name of said company;
  - viii. In case of request for "posthumous mandate" (namely regarding a deceased author who has never been a SIAE's member), the heir or the heirs' representative, etc., must register also the works of the author by using the registration form provided.

The duly signed application form, received complete with all the required documentation, including the deposit of the work, will be considered accepted after 60 calendar days from the date of arrival of the same at SIAE, in accordance with the following methods:

SIAE is always reserved the right to waive the term of 60 calendar days or expressly accept the application even before the afore-mentioned term.

Registration through the application available on *mobile* devices can be finalized online through the electronic signature service, without sending the application for membership by using one of the procedures described above.

In the event of no compliance with the minimum requirements set out in these Conditions of Membership, the registration procedure will be cancelled within the same 60-days term by means of specific communication to the interested party.

In the event that the registered work has already been declared by other associate or mandate members or, if it has already been previously deposited, the relative references should be indicated in the appropriate space provided on the registration form (title, authors and, if available, repertoire) or during the online registration process.

## **PROTECTED RIGHTS AND RIGHTHOLDER'S OPTIONS**

Admission to SIAE entails the issuing to the same of the mandate for the intermediation in an exclusive way of the repertoire protected by the Sections for which an application has been submitted for the categories of rights provided for by Article 3 of SIAE's General Rules and for the territories for which reciprocal representation agreements exist between SIAE and other collecting societies.

The Member/Principal may limit, even after his/her membership, the categories of rights and/or the territories for which protection is requested. This option can be exercised in writing within August 31<sup>st</sup> of each year, with effect from January 1<sup>st</sup> of the following year.

These changes can be made directly through the Authors and Publishers Portal, by registering at the link <https://www.siae.it/it/servizi-online> or by sending the specific form provided, duly completed and signed, via the Certified Electronic Mail provided by SIAE to all rightholders at the address [Comunicazioni.SIAE@pec.siae.it](mailto:Comunicazioni.SIAE@pec.siae.it) The appropriate forms are available on the institutional website (<https://www.siae.it/en/about-us/documents-and-faq/forms>).

Protected rights and/or the territories for which protection is requested may be limited even when applying for membership; in this event, the limitation takes effect on the same day the protection begins.

## LICENSES FOR NON-COMMERCIAL USES

Licenses for non-commercial uses may be granted, pursuant to Article 4, subparagraph 5 of the Decree 35/2017. The procedures related to the exercise of this right are regulated by SIAE's General Rules and may be applied through specific online functions on Authors and Publishers Portal.

## TERMINATION OF THE MANDATE FOR PROTECTION

Pursuant to Article 6, paragraph 7 of SIAE's General Rules, the Member/Principal, up-to-date with the payment of the annual fee, can withdraw the protection mandate or change his/her membership status into a mandate within August 31<sup>st</sup> of each year, with effect from January 1<sup>st</sup> of the following year.

Such withdrawal or change can be exercised directly through the Authors and Publishers Portal, by registering at the link <https://www.siae.it/it/servizi-online> or by sending the duly completed and signed application form for change of membership status via Certified Electronic Mail that SIAE provides to all rightholders at the address [Comunicazioni.SIAE@pec.siae.it](mailto:Comunicazioni.SIAE@pec.siae.it). The above mentioned forms are available on the institutional website (<https://www.siae.it/it/chi-siamo/documenti-efaq/moduli>).

The withdrawal of the mandate for protection does not exclude the right to receive the revenues deriving from uses occurred before the withdrawal is effective, on the basis of the established rules and time scale. In this respect, SIAE provides access to dedicated online services for the next 4 years starting from the effective date of withdrawal of the mandate, thus allowing the person concerned to view and modify his/her personal records, contact details and payment method chosen. Display of the balance and account movements are made available also. Distribution statements on paper will not be sent without prior request from the rightholder.

## MANAGEMENT FEES AND DEDUCTIONS APPLIED

It is underlined that the annual contribution is deducted when payments are made and such deduction is specified on the statement. If the accrued amount of royalties is not sufficient to cover the whole contribution, the Customer Care Service shall ask the difference also by a bank MAV (notice payment form), which is available on the new Authors and Publishers Portal both for downloading and dedicated platform for payments. Non-payment of the fixed annual contribution of which at point a) implies the automatic forfeiture of the protection relationship.

SIAE invests the revenues deriving from copyright pending distribution according to the provisions of Article 14, paragraph 5, of the Legislative Decree 35/2017:

1. Pending the relevant distribution, the revenues deriving from interests on the sums collected are used to set-off or decrease the management costs.
2. The members/principals contribute to the expenses incurred for the management of copyright both through a fee to be paid annually and through deductions from the rights revenue.
3. The fees due are annually published on the Society's website.
